**RESOLUTION FP-15-31**

## **RECOMMENDATION:**

The California Department of Transportation (Department) recommends the California Transportation Commission allocate \$4,361,000 for six State Highway Operation and Protection Program (SHOPP) Minor projects.

## **ISSUE:**

The attached vote list describes six SHOPP projects for \$4,361,000. The Department is ready to proceed with these projects and is requesting an allocation at this time.

## **FINANCIAL RESOLUTION:**

Resolved, that \$4,361,000 be allocated from the Budget Act of 2015, Budget Act Items 2660-303-0042, 2660-302-0042, and 2660-302-0890 for six SHOPP Minor projects described on the attached vote list.

The Department has complied with the National Environmental Policy Act and the California Environmental Quality Act requirements in preparing these projects.
