


State Budget Update

- 2016-17 Budget Bill approved by the State Legislature
 - Increase of approximately \$7 billion in General Fund spending over current year budget
 - Prepares for future economic downturn with \$2 billion supplemental deposit in the State's Rainy Day Fund
- Does not include significant transportation reform or funding

Department of Transportation Budget Update

- 2016-17 Enrolled Budget authorizes \$9.7 billion and 19,045 positions for the Department of Transportation
 - Decrease of approximately \$800 million and 252 positions from the 2015-16 budget

Aeronautics Account

- Executive Order issued by Department of Finance (DOF) on May 23, 2016.
 - Authorizes the transfer of \$1.3 million from the Local Airport Loan Account to the Aeronautics Account.
 - Transfer occurred on June 16, 2016.
- Revised Aeronautics Account Fund Estimate, approved by the Commission at the January 2016 meeting, includes \$1.3 million transfer.
 - \$4 million annual transfers assumed in the Revised Fund Estimate are subject to DOF approval.

Upcoming Events

- July 2016
 - Decrease in Price-Based Excise Tax on gasoline
 - Increase in Excise Tax on diesel
 - California Road Charge Pilot begins
- August 2016
 - Final 2016-17 Allocation Capacity
