ISSUE:

Should the California Transportation Commission (Commission) approve an allocation of \$28,001,000 for Project 113 – Route 46 Widening – Segment 4A (PPNO 3386C) project programmed in the Traffic Congestion Relief Program (TCRP)?

RECOMMENDATION:

The California Department of Transportation (Department) recommends that the Commission approve an allocation of \$28,001,000 for Project 113 – Route 46 Widening – Segment 4A (PPNO 3386C) project in Kern County, programmed in the TCRP.

BACKGROUND:

The attached vote list describes one TCRP project totaling \$28,001,000. The Department is ready to proceed with this project, and is requesting an allocation at this time.

FINANCIAL RESOLUTION:
